179/16 Cllr Bundy gave an update on the results of the Local Authority Reorganisation public consultation. The results show clear backing for change to local government structures in Dorset. In the household survey, almost three quarters support reducing Dorset's councils from nine to two, with over two thirds of open questionnaire respondents also agreeing.
