## 64/20 Declarations of Interest and Grants of Dispensation

## 67/20 Planning Matters

The following planning application/s were considered: -

67.1 **Application No: WD/D/20/001537 –** Pitt Cottage, Ringstead Dairy Access Road, Ringstead, Dorchester, DT2 8NF – Conversion of a derelict former World War II radar bunker into 1.no dwelling.

It was **resolved** to support this application as it was deemed a good use of the land.

67.2 **Application No: WD/D/20/001529 –** 1 Grove Hill, Osmington, Weymouth, DT3 6EZ – Erection of 1.no dwelling (demolition of existing barns).

It was **resolved** to Object to this application for the following reasons;

This is in an inappropriate location and outside of the development boundary; The proposed development is too big for the site.

### 68/20 Parish Amenities

The Playing Field Officer provided a brief update to members. The grass on the playing field continued to be cut. A further update regarding the erection of the fence would be provided at the next meeting.

# 69/20 Highways and Rights of Way

The meeting ended at 7.25pm.

- 69.1 Members were informed that the A353 had been scheduled to be resurfaced in 2021.
- 69.2 It was noted that Shortlake Lane had been particularly busy in recent weeks and some parking issues had been reported by residents. Members agreed that this is something that needed to be addressed ahead of the 2021 summer season and this item would be added as a future agenda item.

#### 70/20 Council Matters
