## 1. Democratic Period

## 2. Planning Applications

**95/15 Application No: WD/D/15/000316** —Outline application to construct 3No. new build cottages with associated garaging. Change of use of an existing stable block to a residential at Mulberry House, Roman Road, Osmington, Weymouth DT3 6ER.

The Council most strongly opposes this application. This proposed development affects many more than the residents of the immediate locale and in view of the considerable number of objections notified to this Council from a wide spectrum of parishioners, the Council is requesting that this application is determined at WDDC Committee level after a site visit has been undertaken in order that the numerous issues raised are fully appreciated. The proposed development is in an unsustainable, remote location and would be contrary to both the National Planning Policy Framework (2012) and the West Dorset/Weymouth & Portland Local Plan Policy HOUS6. The claim by the applicant that there are two in number public houses within walking distance of the site is incorrect. There is only one within practicable walking distance within the village. References to ready accessibility to the village by bus are grossly exaggerated. No such integrated service exists. Other applications locally have been refused for similar reasons. Osmington has no defined development boundary and the proposed development fulfils no criteria that may apply given that there has been no demonstration of local need via any housing needs survey. The proposed development would be accessed only from the adjacent bridleway known as the Roman Road, an extremely popular route to the South Dorset Ridgeway for the local equestrian and dog walking community, large groups of pedal cycling schoolchildren from the nearby PGL Outdoor Education Centre and rambler walkers. The likely 40% increase in vehicular traffic resulting from this development would increase the conflict with and reduce the safety of both existing and intended new users of this narrow and distinctly rural route.
