The Sly Fox update – Mr S Bainbridge provided a brief update to members regarding the planning application and a delay that had occurred in the process. It was noted that due to a comment submitted by the council it was not possible to progress the application and the applicant requested that members review the comment made and consider its retraction.

It was **resolved** unanimously that the comment "It was requested that the cottage be linked to the pub as an income stream" (30/23 – 11th April) be retracted.
