# OSMINGTON PARISH COUNCIL

Minutes of the Ordinary Meeting of the Parish Council held on Monday 5<sup>th</sup> September at 7.00pm at the Village Hall

Apologies.

**134/16** Apologies received from Cllr N Bundy.

Public Attendance.

**135/16** Four members of the public were in attendance.

**Public Participation Time.** 

136/16 Cllr Canning gave an update regarding the consultation on the creation of unitary local authorities across Dorset.

Cllr Ireland asked whether Town Councils would be created where Districts and Boroughs were no longer in existence – there was nothing in the documentation to address this. Cllr Canning responded stating it was not clear what would happen if the unitary authorities went ahead.

Dorset County Council will be aiming to look at the speed issue at Osmington Hill by the end of September.

137/16 Cllr Thacker also updated the Council about the creation of unitary local authorities across Dorset.

Cllr White asked whether there were safeguards for the Dorset Waste Partnership regarding the partnerships overspend. Cllr Thacker assured the Council that this should not be a problem now, as the financial problems were at the beginning of the partnership and had been addressed.

Ms Bramley spoke regarding the agenda item for a booking procedure for the playing field.

Ms Bramley stated that the playing field was given to the residents of Osmington for their use and a formal booking procedure would not work. At present members of the public notify the Village Hall through the Osmington Online website and that is all that should be required.

Mr Banks spoke regarding the agenda item for the pruning/felling of trees on his property boundary adjoining the Osmington playing field. Mr Banks has previously paid for work to be carried out on the trees, but as the trees are on the Osmington playing field, he would like the Parish Council to pay for the pruning of them in future. Mr Banks stated that he suffers from respiratory problems due to the trees pollen and fungus and cutting them back would alleviate this.
